1. Mission of and Steps and Keys to Incorporate RoCCIJa

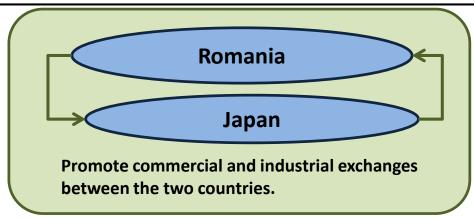
Practicing Strategic Innovation

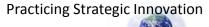
4. Potential Industrial/Economic Developments in Romania with Japan Strategic Innovation

Checking the current industrial conditions and positions between Romania and Japan, let us discuss, specify and project the possibility of industrial/economic developments of Romania in cooperation with Japanese firms.

Industry	Issues	Opportunities	Risks
Agriculture/ Farming	Agriculture is still a major industry in Romania. More profitable and sustainable farming is expected.	Possible to adapt micro-ecosystem as agricultural materials to reduce chemical fertilizer and increase productivity and quality of Romanian agricultural produces.	Must be determined: probably opposed by the global chemical majors.
Fiber, Textile	Textile is still major but declining due to competition with China. Industrial rehabilitation is needed taking advantage of Romania's traditional techniques and qualities.	Textile industry in Japan is also drastically declining. Still, Japan is hanging on with her robust traditional strengths like in silk industry. Also Japan-made low-price fashion brand, like Unicro, is currently emerging globally. It might be possible for Romanian textile industries to resurge by going hand in hand with Japanese partners.	Must balance in co- existence with the existing fashion brands of France, Italia, etc. in Europe.
ICT/Electronics	Romania has a strong software industry. But most of them are under the control of foreign major ICT/electronics firms.	There maybe a possibility for Japanese ICT industry to branch out in Romania as a base center and together we may enhance Romanian ICT products to a global standard.	Must face the severe global competitions in the world's software industries.
Medical	Medical services in Romania are highly qualified but not well known enough overseas.	Promoting medical tourism from Japan to Romania would let the Japanese know and enjoy Romanian medicine.	Must overcome language and culture gaps. Guarantee against medical mistake is needed.
Automobile	Romania has a strong automobile industry including automotive suppliers. Unfortunately, most of them tend to be reduced legacy ones.	Possible to develop electric/hydrogen car industry with strong technical supports from Japan, of major-to-minor automotive firms. Together, R-J could prevail in a global eco-car markets.	Must face and win severe global competitions over eco-car developments with among the world's major and minor auto makers.

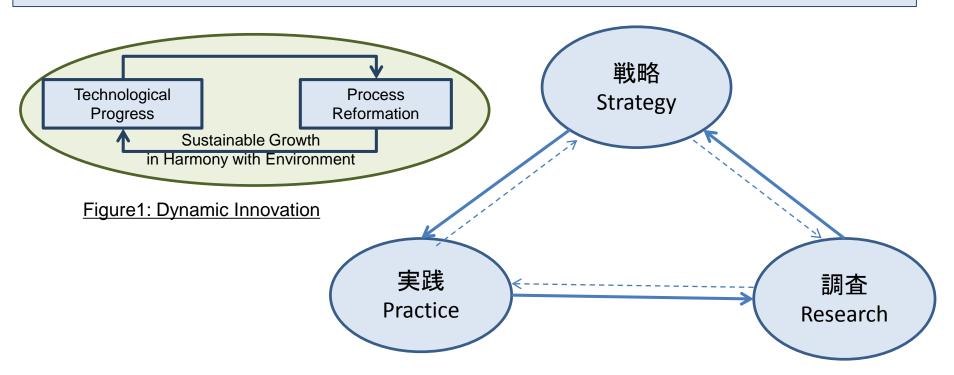


Figure 2: Our Consultation Trinity: Research, Strategy and Practice

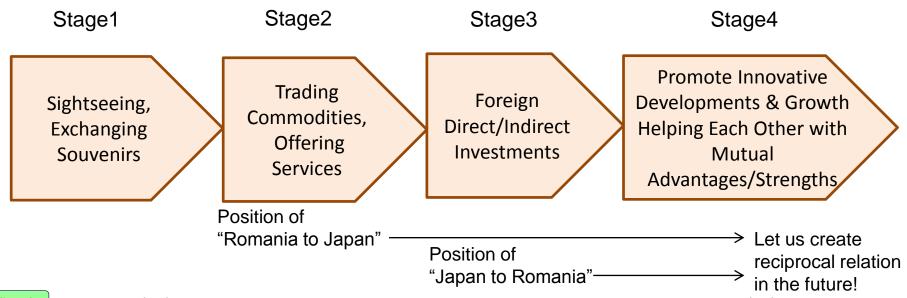
